

# **General Terms & Conditions**

Janene Liston Coaching & Consulting (i.e. the Coach) provides coaching and consulting services for small businesses. Articles and programs offer ideas & instruction on pricing, marketing, communication, and other aspects of business and leadership.

## **Payment Terms**

Payment is required in full at the time of booking for all programs unless otherwise agreed in writing. The Coach shall charge a 5% (five percent) late penalty fee to all payment plan balances that are not paid within 7 working days by the Client. In the event that Client is in delay with payments to Company, Client shall be barred from using any of the Company's services.

## Coaching Program Cancellation Policy

The Client can decide to terminate the coaching at any time upon a 2-week prior written notice to the Coach. It is understood that fees paid until the termination date will not be refunded. Cancellation notification must be received in writing via email or standard post.

For one-to-one coaching please refer to the terms in our contract.

## Make Up Sessions & No Shows

One-to-one sessions can only be rescheduled if notice is received at least 24 hours in advance of the originally scheduled appointment per the cancellation policy above.

For group programs (like courses and group coaching) make-up sessions are not available.

There are no refunds or make-up sessions for "no shows".

## **Refund Policy**

Refunds are not offered to the Client for change of mind. This purchase is not transferable or assignable by the Client to a third party without the Coach's prior written consent.

For Workshops: Full refunds (minus any payment processing fees) will be granted if at least 10 business days advance notice is given. For Workshops Series, that's 10 business days in advance of the first workshop.

For Challenges & Self-Paced Online Programs: Once access has been granted to the program and/or the program starts no refunds for change of mind will be given.

For Other Online Group Programs: Should the Client wish a refund for cancellation of its enrollment; it must notify the Coach within 14 days of purchase or enrollment with a valid reason, which is also reasonable to the Coach for a refund request. Evidence of program participation will be required upon Coach's request. The costs for use of any session or product used by the Client and an administration fee of 15% will be deducted from the total refunded fee. Any refund amount granted will be made at the sole discretion of the Coach and, if granted, by the same method that the Client made the initial payment.
